Be a Marigold

My principal shared the following story two years ago, and it has stuck with me since. It reminds me of how we can all help and enjoy our organizations.

THE MARIGOLD EFFECT

Many experienced gardeners follow a concept called *companion planting*: placing certain vegetables and plants near each other to improve growth for one or both plants. For example, rose growers often plant garlic near their roses because it repels bugs and prevents fungal diseases.

Among companion plants, the marigold is one of the best. It protects a wide variety of plants from pests and harmful weeds. If you plant a marigold beside most any garden vegetable, that vegetable will grow big and strong and healthy, protected and encouraged by its marigold.

Marigolds exist in schools as well as all organizations – encouraging, supporting, nurturing, and empowering. Marigolds remain positive in the face of adversity (without being naïve or unrealistic). They share their best ideas and resources because they want to see **everyone** succeed. They embody what it means to be a good teammate and enable their peers to withstand the storms and continue to flourish. If you can find at least one marigold in your organization and stay close to them, you will grow. Find more than one and you will positively thrive. Simply put, *surround yourself with good people*.

- Take care of any treasurer duties that are easy to put off during the year, such as updating vouchers, sending donations to International, and organizing paperwork you have collected.
- Make yourself a cup of _____ (your choice) and get acquainted with the new layout of www.dkg.org. I ventured onto the site and found it easy to navigate and find all my favorite forms and resources. When you go to the website, remember to sign in (green banner at the top of the page) to get access to all your DKG resources and benefits.
- Visit our own state's DKG website. You can type in wydkg.weebly.com, or you can find a link to the site at www.dkg.org. After you sign in, click on *About* and click on *State Org & Chapter Websites* at the very bottom of the menu.
- Work with your chapter members to update their information in the DKG portal. Current information ensures that members are getting their DKG benefits, and it also helps our own editor, Glenda Reynolds, to get this Round-Up to all members.

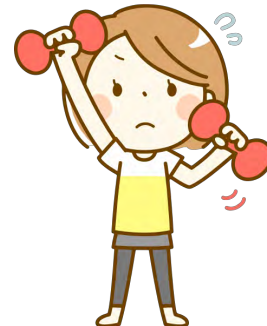

Apply for the State Scholarship

The Wyoming State Scholarship for graduate and postgraduate work is awarded to active members who have been in the Wyoming State Delta Kappa Gamma for at least two years.

One scholarship in the amount of \$1,000 will be announced at the Wyoming State Conference in the spring.

Due each APRIL 1

No late applications will be accepted.

Applications may be submitted by postal mail or email.



Wyoming State Regulations:

The Wyoming State Scholarship is available to active members in good standing in a chapter of the Wyoming State of the Delta Kappa Gamma Society International for at least two (2) years. Preference will be given to members who have shown leadership in Delta Kappa Gamma.

An applicant must be accepted for graduate work in an approved institution of higher learning. If postgraduate studies have been pursued, the applicant must be in good standing.

An applicant must plan to use the scholarship to pursue graduate work or seeking an advanced degree.

An applicant must be currently employed in educational work or be planning to return to employment in the field of education upon completion of graduate studies.

Previously unsuccessful applicants may apply again, but recipients are ineligible for future scholarships.

Directions for Applying for the Scholarship:

The form can be found by clicking on the link [Scholarship Application Form](#) or on the Wyoming State Website: www.wydkg.weebly.com

The application must be returned to the state chairperson, Dr. Irene Story, **no later than April 1.**

The applicant must submit three (3) letters of recommendation from persons qualified to speak specifically of character, ability, and scholarship. These letters should include a current professional co-worker and the chapter president.

General Conditions of Acceptance:

Within two (2) weeks after the successful applicant is notified of her selection, she must notify the state scholarship chairperson of her acceptance of the award and provide a picture.

No funds will be disbursed until the photo is received.

The acceptance of a scholarship implies the obligation on the part of the recipient to devote herself unreservedly to study within the field of education.

Upon completion of the session for which the scholarship is awarded, the recipient will advise the scholarship chairperson of her progress.

- ___ Completed application form (4 copies total, if by mail)
- ___ 3 letters of recommendation (4 copies total, if by mail)
- ___ ALL postmarked or emailed to state scholarship chairperson on or before April 1

Payment of Scholarship:

Payment to the recipient will be made by the State Treasurer.

NOTE: The deadline for the Achievement Award is March 1, 2023.

Nomination Guidelines

THE NOMINEE:

Must be an active member (reserve and honorary are not eligible).

Shall have made outstanding contributions to Delta Kappa Gamma on more than one level (chapter, state, international).

Should be recognized outside of Delta Kappa Gamma activities with emphasis on educational contributions and community and state service.

Is to be **unaware** of the nomination.



THE CHAPTER

Shall submit their nominee's required resume which follows the above guidelines in Word format to the state chairman by **March 1, 2023**. Nominations received after that date will not be considered.

NOTE: The nominee may be from your own chapter or from another chapter in the state. The resume will be in outline form, which is included in these guidelines.

News clippings, pictures, etc. will be excluded from the resume, but chapters may gather and assemble information to be placed in the Achievement Award scrapbook should their nominee be the recipient.

The resume shall not exceed four (4) pages of 8 ½ x 11-inch paper (i.e., four computer pages.)

A **photograph** should be part of the resume.

The nominee should not be the current state president.

Chapters need **to email a copy** for the Wyoming State Organization Achievement Award chairman by **March 1, 2023**. Submit your copy as a **WORD Document, not PDF**. **A hard copy is not necessary unless requested by the Chair(s) of the Achievement Committee.**

- Participated in a prescribed number of international conferences/conventions

- Held a certain number of specific state positions

- Been a member for a minimum number of years

The duties and responsibilities of the elected INC members are outlined in the Constitution Article VIII Section B.8.b. INC members MAY NOT...

- Recruit applicants

- Assist applicants in any way with the application process

- Discuss any application with anyone other than another INC member

- Support or advocate for any nominee in any way

Act now! Evaluate your interests and skills with the qualifications listed in SR 8.82.f noted above.

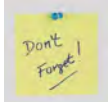
Our second half of the year will continue with monthly meetings with more great programs, book sale grants for our community, and Founder’s Day.
